Angela: Once again you are talking about things that you know nothing about. Documents pertaining to the Dayton Prairie Groundwater Management Advisory Board do go back more than ten years because that was part of the lawsuits filed to prevent the cities from constructing the wells or obtaining water rights. I'm attaching the settlement agreement, signed by the Mayor of Lafayette in 2000 that designates that there will be a representative from each city. I was told I was the representative when I got here and have been ever since. We have not paid any fees associated with this board. If you request further information concerning this group, you are going to have to be more specific in what you want. Any unspecific requests will require more staff time than I'm sure you will be willing to pay for. Diane
