There is the Dayton Prairie Water Association. And there is the Dayton Prairie Groundwater Management Advisory Board.

I am looking only for information on the latter. This was a board filed with the state in 2002. So, the records shouldn't go back that far (10 - 12 years).

Specifically, at the current time, I am looking for the time period the council authorized the city administrator to be a member of the board filed with the state. Dayton cannot locate a payment made to the state for the renewal of this fee from last November. I cannot locate one made by the City of Lafayette. Yet, the state advises it was

Since the plan is to keep everyone in the loop, here is the original response. What Diane is forwarding was for another request. A request that still has not been responded to and has been filed with the District Attorney. Chris Heisler will be receiving a copy of that from DA Berry.

Attached, you will find the information filed with the state by Diane Rinks and Sue Hollis. This includes the original articles of incorporation, which happened in 2002 (not before that date). This was the initial start date of the entity as far as the state is concerned. Not a change of members. The state has no reason why this entity was formed, including any city authorization. You will note, payment was renewed in November, 2008. This was done by an unknown source. The state does not know who paid. Lafayette didn't. Neither did Dayton. But, Sue Hollis was terminated in September of 2008 and it was not appropriate for her to even be on there anymore if this truly is an entity started for a city. Since Dayton did not have any records available regarding the existence of this entity, they did not even know to have her removed. They are taking care of that now.

So, Dayton is having their archivist look into the matter to see if any information can be found. I was doing the same. Obviously, I knew there would be a cost involved. I am prepared to pay it. But, knowing I will not be refunded money to be provided documents I am not asking for (as has happened to me in the past), I want to be sure that both parties are discussing the same entity.

I chose my words carefully when responding to Trena. I was not snarky. But, in true form, that is exactly what I received back. It's really not funny, but the more direct my questions, the more sarcastic the response.

So, we are all on the same page now. Hopefully, someone can help figure this out. Or provide me a price. This request was originally done on 6/24/2009. So, the timeline has passed. Unless someone wants to guarantee me a refund for the issuance of documents not requested, lets just get some information out here.
